<p>The professional training of a political scientist is focused on the study of the system of political relations, domestic and foreign policy processes (cooperation, integration, international conflicts), and on theoretical-applied and professional training of bachelor's students, which is carried out through collaboration with structural units of public authorities responsible for the formation and implementation of the country's domestic and foreign policy, international organisations, etc.; and foreign language proficiency.</p> <p><i>Keywords:</i> political science, domestic policy, foreign policy, international organisations, integration processes.</p>

5-TEACHING AND ASSESSMENT
<i>Teaching And Learning</i>
Student-centred learning, self-study, problem-based learning, an individualised, creative approach, and learning through practical training. The system of teaching methods is based on the principles of purposefulness and binarity – active direct participation of both the teacher and student in the learning process. The main approaches to teaching and learning are humanistic, systematic, technological and discrete. The main types of learning activities are lectures, practical classes, independent work, teacher consultations, project development, and practical training.
<i>Assessment</i>
The assessment of students' learning outcomes is carried out by the 'Regulations on the assessment of students' and postgraduate students' learning outcomes at SUTE and involves the following control measures: ongoing and final assessments, and attestation. Ongoing control (testing, project defence, solving situational tasks (cases), business games, etc.) is carried out during practical/laboratory classes and based on the results of individual course work. It involves assessing students' theoretical preparation during seminar work and the practical skills acquired while performing laboratory/practical tasks. Final assessment consists of control measures that determine the compliance (measurement, evaluation) of the learning outcomes achieved by a person with the requirements of the educational programme in terms of the relevant educational component, which is carried out at the university in the form of a credit and an exam. The learning outcomes of students at SUTE are assessed on a 100-point scale, where: 60-100 points – learning outcomes that entitle the student to obtain ECTS credits; 0-59 points – unsatisfactory learning outcomes that do not entitle the student to obtain ECTS credits.

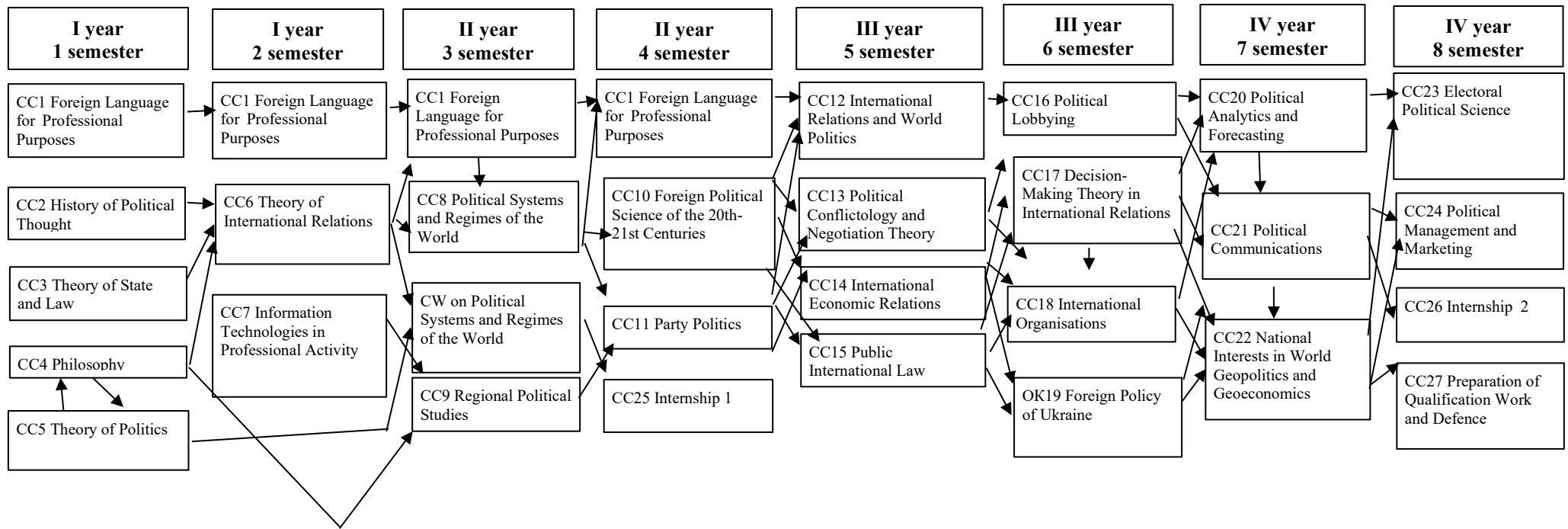
